**使用说明**

**1. 无线控制**  
RC-A5具备控制功能, 使用433MHz无线, 可以分别控制6个LED摄影灯, 拥有16组传输频道, 抗干扰性强。  
使用前请将 LED 摄影灯与 RC-A5 遥控器频道、组别调至一致。

**2. 使用遥控器调整频道/组别**

- 按CH/GRP按钮, 组别图标闪烁。按“-”或“+”按键选择组别, 可选范围: A-F。
- 按CH/GRP按钮两次, 频道图标闪烁。按“-”或“+”按键选择频道, 可选范围: 1-16。

**3. 使用遥控器调节灯光亮度**

- 遥控器色温值为3300K或色温值为5600K时, 短按“-”或“+”按键调节灯光亮度, 调节范围: 10%-100%。
- 遥控器色温值为3400K-5500K时, 短按“-”或“+”按键调节灯光亮度, 调节范围: 25%-100%。

**4. 使用遥控器调节色温**

- 短按遥控器SET按键, 色温图标闪烁。按“-”或“+”按键调节色温, 调节范围: 3300K-5600K

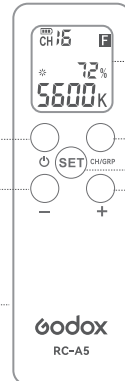

**Operation**

**1. Wireless Control**

With 433MHz wireless, RC-A5 has control function. Up to 6 groups of LED lights can be controlled. 16 channels are available with strong anti-interference capability.

Please set the channels and groups of LED light to the same as those of RC-A5 remote control before usage.

**2. Adjusting Channel/Group with the Remote Control**

- Press the CH/GRP button and the group icon blinks. Press the“-”/“+”button to choose a group (A to F).
- Press the CH/GRP button twice and the channel icon blinks. Press the“-”/“+”button to choose a channel (1 to 16).

**3. Adjusting Light Brightness with the Remote Control**

- When the CCT value is 3300K or 5600K, short press the“-”/“+”button to adjust the light brightness from 10% to 100%.
- When the CCT value is between 3400K to 5500K, short press the“-”/“+”button to adjust the light brightness from 25% to 100%.

**4. Adjusting Color Temperature with the Remote Control**

- Short press the SET button and the color temperature icon blinks. Press the“-”/“+”button to adjust the color temperature from 3300K to 5600K.
